FIRST AMENDMENT TO THE AGREEMENT BETWEEN THE COUNTY OF SHASTA AND LEXIPOL, LLC

This first Amendment is entered into between the County of Shasta ("Agency"), a political subdivision of the State of California, and Lexipol, LLC, a Delaware limited liability company ("Lexipol").

RECITALS

WHEREAS, Agency and Lexipol have previously entered into an agreement on August 1, 2016 to provide for comprehensive, defensible policies written by legal and public safety professionals ("Agreement"); and

WHEREAS, Agency and Lexipol desire to amend the Agreement to add comprehensive, defensible policies specific to the Shasta County Sheriff's Office Custody division to the agreement and increase the amount compensation payable to Lexipol by \$8,818 annually, with a first year prorate amount of \$5,879 for a total maximum compensation of \$40,765 over the term of the contract.

NOW, THEREFORE, the Agreement is amended as follows:
