## AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SHASTA SETTING FEES TO BE CHARGED BY THE CLERK OF THE BOARD AND REPEALING ORDINANCE NUMBER 584

The Board of Supervisors of the County of Shasta ordains as follows:

- SECTION 1. The purpose of this ordinance is to set fees in reasonable amounts to cover costs of providing certain services and supplies furnished by the Clerk of the Board.
- SECTION 2. The authority for the fees established herein is found in in Government Code sections 26833, 26836 and 54985, and Revenue and Taxation Code section 1611.5.
- SECTION 3. The fees set forth herein and adopted by this ordinance are not a tax as defined by section 1(e) of Article XIII C of the California Constitution and are exempt from voter approval under section 1(e)(1)-(4). These fees are imposed for a specific government service provided directly to the applicant or recipient that is not provided to those not charged; are imposed for use of government property; and are imposed for the reasonable regulatory costs to the County of permitting and the administrative enforcement thereof, or do not exceed the reasonable costs to the County of providing these services.
- SECTION 4. The fees set forth in column 1 of Attachment A are hereby adopted. The fees set forth in column 2 of Attachment A include fees that are set by other entities over which the Board of Supervisors has no discretion in the amount charged or in the setting of the fee. The fees identified in column 2 of Attachment A may be modified by the entity setting those fees and the total fee collected by the Clerk of the Board set forth in Column 3 of Attachment A may be modified in accordance with those changes without further action by the Board of Supervisors.
- SECTION 5. This ordinance is not intended to contain all fees that are or may be charged by the Clerk of the Board for services and supplies and to the extent that other fees are customarily charged or are established elsewhere and are not listed below, all such fees, charges, and rates shall remain in full force and effect.
- SECTION 6. Notice of the introduction of this ordinance has been given and a public meeting and hearing held pursuant to sections 26833, 26836, 54985, and 66018 of the Government Code, and section 1611.5 of the Revenue and Taxation Code and that the fees authorized by this ordinance have been set at an amount which does not exceed the costs incurred for providing the products, or performing the services and tasks, enumerated herein.
- SECTION 7. Should any fee herein established be held to be invalid or otherwise unenforceable, such determination shall not affect the validity of the remainder of this ordinance or the remaining fee provisions.
- SECTION 8. This ordinance repeals Ordinance No. 584 adopted October 11, 1994, and any prior ordinance or resolution setting any of the fees set forth in Attachment A.
