# FIRST AMENDMENT TO THE PERSONAL SERVICES AGREEMENT BETWEEN THE COUNTY OF SHASTA AND ABOUT TIME RECOVERY, INC.

This First Amendment is entered into between the County of Shasta, through its Health and Human Services Agency, a political subdivision of the State of California ("County"), and About Time Recovery, Inc., a California Corporation ("Contractor"), (collectively, the "Parties" and individually a "Party").

#### <u>RECITALS</u>

WHEREAS, County and Contractor have previously entered into an agreement on May 3, 2022, effective May 5, 2022 to provide Sober Living/Recovery Residences services and other therapeutic services ("Original Agreement"); and

WHEREAS, County and Contractor desire to amend the Agreement to increase the amount of compensation payable to Contractor by \$115,000 due to an increase in client services from what was initially projected and budgeted ("First Amendment"); and

WHEREAS, the Original Agreement and the First Amendment are collectively referred to as the "Agreement."

NOW, THEREFORE, the Agreement is amended as follows:

- I. **Section 4.B.** <u>COMPENSATION.</u> of the Agreement is amended effective December 1, 2022 in its entirety to read as follows:
  - B. In no case whatsoever shall the maximum amount payable under this agreement exceed \$217,000 during the term of this agreement.

#### II. **REAFFIRMATION**

In all other respects, the Agreement, as amended, and any attachments, remains in full force and effect.

#### III. ENTIRE AGREEMENT

The Agreement, as amended, and any attachments, constitute the entire understanding between County and Contractor.

### IV. EFFECTIVE DATE

Unless otherwise provided, this First Amendment shall be deemed effective December 1, 2022.
