**A RESOLUTION OF THE BOARD OF SUPERVISORS OF SHASTA COUNTY
AUTHORIZING APPLICATION FOR, AND RECEIPT OF, CALIFORNIA
DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT FUNDING
UNDER THE NO PLACE LIKE HOME PROGRAM TECHNICAL ASSISTANCE
GRANT**

WHEREAS, the State of California, Department of Housing and Community Development (“HCD”) has issued a Notice of Funding Availability dated April 10, 2017 (“NOFA”), for its No Place Like Home (“NPLH”) Program Technical Assistance Grants; and

WHEREAS, NPLH funds are authorized by Government Code Section 15463, Part 3.9 of Division 5 of the Welfare and Institutions Code §5849.10; and

WHEREAS, the County of Shasta desires to submit a project application for the NPLH Program and will submit a 2017 Technical Assistance Grant Application as described in the NPLH Program Technical Assistance Grants NOFA and NPLH Program Technical Assistance Grant Guidelines released by the HCD for the NPLH Program; and

WHEREAS, the HCD is authorized to provide up to \$6.2 million from the Mental Health Services Act Fund for technical assistance and application preparation assistance to counties (as described in Welfare and Institutions Code §5849.10) related to the NPLH Program; and

WHEREAS, in response to the April 10, 2017 NOFA, the County of Shasta (“County”) wishes to apply to HCD for, and receive an allocation, of NPLH funds.

NOW, THEREFORE, BE IT RESOLVED: by the Board of Supervisors of the County of Shasta that in response to the April 10, 2017 NOFA, the County shall submit an application to HCD to participate in the NPLH program and for an allocation of funds in the amount of \$75,000 for the planning of permanent supportive housing for individuals who suffer from serious mental illness.

BE IT FUTHER RESOLVED that the County’s Director of the Department of Housing and Community Action Programs is authorized and directed to sign and submit the grant application and all other application documents necessary to secure the grant.
