

**FIRST AMENDMENT  
TO THE  
PERSONAL SERVICES AGREEMENT  
BETWEEN  
THE COUNTY OF SHASTA AND  
PACE ENGINEERING, INC.**

This First Amendment is entered into between the County of Shasta, a political subdivision of the State of California through the Department of Public Works ("County") and PACE Engineering, Inc., ("Consultant").

RECITALS

WHEREAS, County and Consultant have previously entered into an agreement that commenced on February 19, 2016, (the "Agreement") for the purpose of providing on call technical support of telemetric systems for the County facilities. (the "Original Agreement"); and

WHEREAS, County and Consultant desire to amend the responsibilities of Consultant, to include Exhibit B, Exhibit B-1, and increase the maximum amount of compensation payable to Consultant by \$50,000.00.

NOW, THEREFORE, the Agreement is amended as follows:

- I. Section 3 of the Agreement entitled "COMPENSATION" is amended in its entirety to read as follows:

**Section 3. COMPENSATION.**

- A. Consultant shall be paid on a time and materials basis. Consultant shall submit invoices for the services described in Section 1 of this agreement, at the rates provided in Exhibits B and B-1, herein attached and incorporated into this agreement.
- B. In no event shall compensation paid to Consultant pursuant to this agreement exceed \$100,000.

**III. REAFFIRMATION.**

In all other respects, the Agreement, as amended, and any attachments, remains in full force and effect.

**IV. ENTIRE AGREEMENT**

The Agreement, as amended, and any attachments and exhibits hereto, constitutes the entire understanding between County and Consultant concerning the subject matter contained herein.

**V. EFFECTIVE DATE.**

Unless otherwise provided, this First Amendment shall be deemed effective as of the date it is signed by both parties.


