# FIRST AMENDMENT TO THE AGREEMENT BETWEEN THE COUNTY OF SHASTA AND SHASTA WOMEN'S REFUGE, INC. DBA ONE SAFE PLACE FOR LEGAL ADVOCACY SERVICES

This First Amendment is entered into between the County of Shasta ("County"), a political subdivision of the State of California, California through its District Attorney's Office – Crime Victims' Assistance Center ("County"), and Shasta Women's Refuge, Inc., dba One Safe Place ("Contractor"), a California corporation.

#### RECITALS

WHEREAS, County and Contractor have previously entered into an agreement on June 28, 2016, for Legal Advocacy Services to victims of violent crimes in Shasta County; and

WHEREAS, County and Contractor desire to amend the Agreement to extend the term of the Agreement to December 31, 2019, and to increase the maximum compensation payable to Contractor from \$67,272 to \$116,137;

NOW, THEREFORE, the Agreement is amended as follows:

I. Paragraphs A and B of Section 3. Compensation of the Agreement are amended as of the effective date of this First Amendment to read as follows:

#### Section 3. <u>COMPENSATION</u>.

- A. Contractor shall be paid \$16.17 per hour for the services described in this agreement, or 25% of total proceeds (which equals 20% of the total project cost) collected by County from the County Victim Services (XC) Program grant through the California Governor's Office of Emergency Services, whichever amount is less.
- B. During County Fiscal Year 2016-2017, the maximum amount payable to Contractor shall not exceed \$33,484, and during County Fiscal Year 2017-2018, the maximum amount payable to Contractor shall not exceed \$33,788. For the period of July 1, 2018 through December 31, 2019, the maximum amount payable to Contractor shall not exceed \$48,865. In no event shall the maximum amount under this Agreement exceed \$116,137 during the entire term of the Agreement. For the purposes of this Agreement, the County fiscal year commences on July 1 and ends on June 30 of the following year.
- II. Section 5. Term of Agreement of the Agreement is amended as of the effective date of this First Amendment in its entirety to read as follows:

## Section 5. <u>TERM OF AGREEMENT</u>.

This agreement shall commence June 28, 2016 and shall end December 31, 2019.

## III. REAFFIRMATION

In all other respects, the Agreement, as amended, and any attachments, remains in full force and effect.

### IV. <u>ENTIRE AGREEMENT</u>

The Agreement, as amended, and any attachments, constitute the entire understanding between County and Contractor.

## V. <u>EFFECTIVE DATE</u>

Unless otherwise provided, this First Amendment shall be deemed effective as of the last date it is signed by both parties.
