

RESOLUTION NO. 2017-

**A RESOLUTION OF THE BOARD OF SUPERVISORS
OF THE COUNTY OF SHASTA
DESIGNATING THE REDDING LIBRARY
TO RECEIVE THE LOCAL APPOINTMENTS LIST (MADDY ACT LIST)
AND
NOTICES OF VACANCY POSTINGS
PURSUANT TO GOVERNMENT CODE SECTION 54973**

WHEREAS, the Legislature of the State of California (Legislature) pursuant to Government Code section 54970, finds and declares that a vast and largely untapped reservoir of talent exists among the citizenry of the State of California (state), and that rich and varied segments of this great human resource are, all too frequently, not aware of the many opportunities which exist to participate in and serve on local regulatory and advisory boards, commissions, and committees; and

WHEREAS, the Legislature, pursuant to Government Code section 54970, further finds and declares that all citizens of the state, regardless of their place of residence should have equal access to specific and current information about the many local regulating and advisory boards, commissions, and committees and equal opportunity to be informed of vacancies which shall occur thereon, so that they may pursue the opportunity to participate in and contribute to the operations of local government by serving on such boards, commissions, and committees, and that this shall apply to all cities and all counties throughout California, including charter cities and charter counties; and

WHEREAS, pursuant to Government Code section 54972, on or before December 31 of each year, each legislative body shall prepare an appointments list of all regular and ongoing boards, commissions, and committees which are appointed by the legislative body of the local agency. This list shall be known as the Local Appointments List, also known as the Maddy Act List (List). The list shall contain the following information: (a) a list of all appointive terms which will expire during the next calendar year, with the name of the incumbent appointee, the date of appointment, the date the term expires, and the necessary qualifications for the position; and (b) a list of all boards, commissions, and committees whose members serve at the pleasure of the legislative body, and the necessary qualifications for each position; and

WHEREAS, pursuant to Government Code section 54973, the legislative body shall designate the public library with the largest service population within its jurisdiction to receive a copy of the List.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Shasta hereby designates the Redding Library as the Shasta County library serving the largest service population within its jurisdiction to receive a copy of the List and all Notices of Vacancy postings.
