Subject: District Attorney/Victim Assistance - Cost Center 25600 Budget Amendment

Please prepare a budget amendment as noted on the attached budget amendment worksheet subject to Board of Supervisor's approval on November 7, 2017. The budget amendment includes increases to appropriations for Cost Center 25600 in the amount of \$67,699 and increases to revenues in the amount of \$87,858.

The budget amendment includes increases to state revenues to recognize the CAL OES grant revenue in the amount of \$71,685 that was not included in the Fiscal Year 2017-2018 budget submission due to budget process timing and also to recognize additional revenue in the amount of \$16,173 which will be received from the Community Corrections Partnership during Fiscal Year 2017-2018. Appropriations are also being increased by \$67,699 to more closely align with actual expenses.
