FIRST AMENDMENT TO THE AGREEMENT BETWEEN THE COUNTY OF SHASTA AND PACE ENGINEERING, INC. FOR CSA #6 JONES VALLEY LEAK DETECTION AND METER REPLACEMENT PROJECT

This first Amendment is entered into between the County of Shasta ("County"), a political subdivision of the State of California, and PACE Engineering, Inc. a California corporation, ("Consultant").

RECITALS

WHEREAS, County and Consultant have previously entered into an agreement on July 18, 2017 to provide engineering services for the CSA #6 Jones Valley Leak Detection and Meter Replacement Project ("Agreement"); and

WHEREAS, County and Consultant desire to amend the Agreement to change the scope of services and compensation for the services to be provided herein for additional CEQA review and to add a federal environmental documentation (NEPA) provision;

NOW, THEREFORE, the Agreement is amended as follows:

I. Paragraph D of Section 1. <u>**RESPONSIBILITIES OF CONSULTANT**</u> of the Agreement is amended as of the effective date of this first Amendment in its entirety to read as follows:

D. Review the project, complete studies, and prepare environmental documents to obtain CEQA and NEPA environmental clearances.

II. Paragraph A of Section 3. <u>COMPENSATION</u> of the Agreement is amended as of the effective date of this first Amendment in its entirety to read as follows:

A. Consultant shall submit invoices for successful completion of the services described in Section 1 of this agreement, at the rates provided in Exhibit B, attached hereto and incorporated herein, in an amount not to exceed \$128,900.00 as described in Exhibit C, attached hereto and incorporated herein.
