### SECTION 5. Water Use Limitations

- A water consumer may apply for a variance from the maximum permitted water consumption provisions prescribed in Section 5.A. by submitting a written request for a variance to the Director of the Shasta County Department of Public Works or his/her designee ("Director"). The Director shall consider all information provided by the water consumer in determining whether a variance will be granted. The Director may, in his or her sole discretion, grant a variance from the maximum permitted water consumption provisions of Section 5 if the application of the provisions prescribed in 5.A. would constitute an extraordinary hardship. The factors which may be taken into consideration include, but are not limited to: failure to grant such a variance would cause an emergency condition adversely affecting health, sanitation, or fire safety for the public or the person or entity requesting the variance; compliance with the water conservation measures cannot be accomplished due to technical or other limitations; is necessary to avoid or mitigate a significant adverse impact on an endangered or listed protected plant, animal, or aquatic species or critical environmental feature present on the property or to maintain the traditional and natural character of a critical environmental feature; or, other limitations and alternative methods achieving the same level of reduction in water use can be implemented and are specified in the request for the variance.
- (C) If the Director grants a variance, the maximum permitted water consumption shall be as determined by the Director, and the civil penalty provisions prescribed in this Ordinance shall apply to the increased maximum permitted water consumption. The Director shall inform the water consumer seeking a variance of the decision within 30 days of the Director's receipt of the request for a variance. Service of the Director's decision shall be by first-class mail addressed to the water consumer at the address given by the water consumer in the request for a variance and shall be deemed received by the water consumer five days after the date of mailing. The water consumer may appeal the Director's decision to the Shasta County Board of Supervisors ("BOS") by filing an appeal. The water consumer's appeal must be received by the Clerk of the Board within 30 days of the receipt by the water consumer of the Director's decision. The Clerk of the Board shall set the matter for hearing before the BOS and shall inform the water consumer seeking a variance of the BOS's of the date, time and place of the hearing of the appeal and shall inform the water consumer seeking the variance of the BOS decision. The BOS's decision on the appeal shall be final.

Section 2.5

My name is Robin Freeman and I worked hard all my life for what have a paid off truck and a home which I am still paying off. I was injured at work 20 years ago and since then my health and diminished significantly where I need the assistance of a cane to walk about, and spend most of my time on my property tending to my gardens and plants. I am mostly housebound and this is one of the few joys I have in my life, and I have placed a lot of money into my property and we live off some of the fruit and vegetables that I grow. This requires the use of additional water or I lose my investment, and the savings of eating what I grow.

We currently have 7 people living in my home, circumstances out of everyone's control and in this rough economy have made families everywhere to rely on one another and this is an example of that. My son is a disabled veteran, he and his family live with me as they transition out of the military. In order to maintain proper health and sanitation 7 people require much more water the amount allotted in the Ordinance. (Baths for the children sometimes twice a day if the get dirty, washing of everyone's clothes, et cetera).

Additionally, the house is cooled by a evaporative (swamp) cooler that uses water, this is ran 24/7 in the summer months along with two floor fans to keep the house bearable and in the Redding heat this is not always accomplished. This in and of its self should be sufficient to grand a variance of the ordinance for safety and health. My son has already suffered two heat related injuries this month. Furthermore, I have recently installed low flow toilets, and shower heads, with this ordinance in mind I will continue to be mindful about our water usage. Again however the amount allotted in the ordinance will not keep us healthy and safe.

Finally, failure to grant this variance would cause an emergency condition adversely affecting our health, and sanitation. Water conservation measures cannot be accomplished due to the technical and other limitations listed above. With the aforementioned in mind I respectfully request a grant of this variance.

#### Section 2.6

Due to the above mentioned hardships, safety, health, and sanitation concerns I propose a variance to the ordinance in its entirety. I could not estimate the amount of water necessary to survive with my family. We will do our best to conserve water at each turn and appreciate your consideration.
