It will be a public hearing at a regularly scheduled public BOS mtg.

After we receive and review all the appeals, we may need additional info from some of the appellants, and if so, we'll need to contact individuals and get info/etc.

Once we've got all the info we need, then we'll contact each person/everyone and tell them the date/time of the BOS mtg, describe the process, let them know what they need to bring, etc. I *anticipate* us doing this the last part of Oct.

My *guess*, just a *guesstimate* right now, is this will go to the BOS on 11/14 or 12/5, but I could be wrong.

We'll also need to give everyone at least one week notice before the BOS mtg, which will add time to the process.

And we have several cancelled BOS mtgs in Nov. and Dec. (the BOS does not have mtgs on 10/31, 11/21, 11/28, 12/19 and 12/26).

We'll work to get this to the BOS as soon as we can after the filing period closes, but we also want to make sure everyone gets their due process so we'll be contacting everyone in advance of the BOS mtg.

I wish I could be more definitive right now, but I'm sorry I can't.
