PROCLAMATION FIRE PREVENTION WEEK, OCTOBER 9-15, 2016 By motion made, seconded, (Moty/Baugh), and unanimously carried, the Board of Supervisors adopted a proclamation which designates October 9-15, 2016 as Fire Prevention Week in Shasta County.

Shasta County Fire Warden Mike Hebrard and Battalion Chief J.T. Zulliger were present to accept the proclamation. Battalion Chief Zulliger explained the importance of this year's Fire Prevention Week Theme, "Don't Wait – Check the Date," regarding monitoring in-home smoke detectors and replacing them on a regular basis.

## OCTOBER 2016 EMPLOYEE OF THE MONTH HEALTH AND HUMAN SERVICES AGENCY-PUBLIC HEALTH BRANCH ASSISTANT SOCIAL WORKER CHRISTINE WOLFE RESOLUTION NO. 2016-109

At the recommendation of Health and Human Services Agency-Public Health Branch Director Terri Fields-Hosler, and by motion made, seconded (Baugh/Schappell), and unanimously carried, the Board of Supervisors adopted Resolution No. 2016-109, which recognizes Health and Human Services Agency-Public Health Branch Assistant Social Worker Christine Wolfe as Shasta County's Employee of the Month for October 2016.

## <u>COUNTY CLERK/ELECTIONS</u> <u>HIGH SCHOOL VOTER EDUCATION WEEKS</u>

County Clerk/Registrar of Voters Cathy Darling-Allen reported on activities which took place during High School Voter Education Weeks. She described the efforts made by staff to educate students on the electoral process. Ms. Darling-Allen stated that High School Voter Education Weeks events brought in 259 paper voter registrations and 29 student poll workers.

In response to questions from Supervisor Giacomini, Ms. Darling-Allen explained that students can be poll workers at the age of 16. She stated that students can also pre-register to vote at the age of 16 and their information will be kept on file until they reach voting age.

Supervisor Moty commended the students for their participation.

Supervisor Kehoe thanked Ms. Darling-Allen and staff for conducting successful High School Voter Education Week events.

Supervisor Schappell encouraged the students to conduct their own research to form opinions on political issues.

Vernon Lee Price spoke on the item regarding the amendment to the agreement with Northern Valley Catholic Social Service, Inc. and requested that the item be continued to a later date.

In response to questions from Supervisor Baugh, Mr. Price explained that he is concerned with an oversight in the agreement and requested increased transparency.

## CONSENT CALENDAR

By motion made, seconded (Moty/Baugh), and unanimously carried, the Board of Supervisors took the following actions, which were listed on the Consent Calendar, as amended:

Approved the minutes of the meeting held on October 4, 2016, as submitted. (Clerk of the Board)

Approved and authorized the Chairman to sign a retroactive renewal lease with Bert and Karen Boothroyd in the amount of \$8,000 per month (approximately \$1.00 per square foot) plus an additional \$627.31 per month for the period July 1, 2016 through June 30, 2017 with annual Consumer Price Index increases or decreases of no more than three percent on the base amount of rent commencing July 1, 2017, for 8,000 square feet of office space at 1220 Sacramento Street, Redding, California for the period July 1, 2016, through June 30, 2021, with one three-year and six two-year optional renewals with annual Consumer Price Index increases or decreases of no more than three percent. (Health and Human Services Agency (HHSA)-Business and Support Services/HHSA-Regional Services)

Took the following actions to approve and authorize the Health and Human Services Agency to purchase a total of 22 vehicles, not to exceed \$470,204.46 (including all taxes and fees): Approved and authorized County Purchasing to award the bid from Request for Bid (RFB)

No. 17-01 for the purchase of 17 sedans to Crown Motors of Redding, California for a total purchase price of \$328,185.00 (including all taxes and fees); approved and authorized County Purchasing to award the bid from RFB No. 17-02 for the purchase of two vans to Crown Motors of Redding, California for a total purchase price of \$53,308.48 (including all taxes and fees); and approved and authorized County Purchasing to award the bid from RFB No. 17-03 for the purchase of three sport utility vehicles to SJ Denham Chrysler Jeep of Redding, California for a total purchase price of \$88,710.98 (including all taxes and fees). (HHSA-Business and Support Services)

Approved and authorized the Chairman to sign a retroactive renewal agreement with Okechukwu Nwangburuka, MD, in the amount of \$249,600 per fiscal year for the provision of psychiatry services for the period July 1, 2016 through June 30, 2019. (HHSA-Children's Services)

Approved and authorized the Chairman to sign a renewal agreement with North State Security, Inc., with a maximum compensation of \$198,000 (\$66,000 annually) to provide inmate security services off-site of the Shasta County Jail from the date of signing through June 30, 2019. (Sheriff-Jail)

Approved and authorized the Public Works Director to sign a Notice of Completion for the Shasta County Jail HVAC Controls Modernization Project, Contract No. 610413, and record it within 15 days of actual completion of the work. (Public Works)

Approved and authorized the Chairman to sign a letter terminating the March 12, 1996 agreement between the Shasta Lake Fire Protection District and the County of Shasta relating to automatic aid fire protection, effective February 1, 2017. (County Service Area No. 1-County Fire)

# AMENDMENT TO THE AGREEMENT WITH NORTHERN VALLEY CATHOLIC SOCIAL SERVICE, INC.

Health and Human Services Agency-Adult Services Branch Director Dean True addressed Mr. Price's concern regarding an oversight in the initial agreement. He explained that case management services have been provided on an ongoing basis and are now being reflected in the proposed amendment to the agreement.

By motion made, seconded (Kehoe/Baugh), and unanimously carried, the Board of Supervisors approved and authorized the Chairman to sign a retroactive second amendment effective, July 1, 2015, to the agreement with Northern Valley Catholic Social Service, Inc., for the provision of mental health wellness and recovery services which: Adds housing case management services; and increases compensation for Fiscal Years 2015-16 and 2016-17 (from \$217,142 to \$230,142 per fiscal year) for a new maximum compensation of \$695,520 over the term of the agreement and retaining the term June 3, 2014 through June 30, 2017. ## **RESOURCE MANAGEMENT**

#### ZONE AMENDMENT 16-004, CASEY ZONING ORDINANCE NO. 378-2039

This was the time set aside to conduct a public hearing regarding Zone Amendment 16-004, Casey (Big Bend area), which would rezone a parcel on the east side of Kosk Creek Road approximately 1.25 miles northwest of the intersection of Hawkins Creek Road and Summit Lake Road from the Timberland (TL) zone district to the Timber Production (TP) zone district for the purpose of promoting the conservation, management, and utilization of the property. Senior Planner Lio Salazar presented the staff report and recommended its approval. The Affidavit of Publication and Notice of Hearing are on file with the Clerk of the Board.

The public hearing was opened. Jim Chapin, the applicant's representative, presented concerns with the fees associated with the rezone.

In response to questions from Chairman Giacomini, Mr. Chapin stated that he could not provide the dollar amount of tax savings to the applicant associated with the rezone.

In response to questions from Supervisor Kehoe, Mr. Chapin confirmed that he was not in attendance at the Planning Commission meeting where this item was recommended.

In response to questions from Supervisor Kehoe, Director of Resource Management Rick Simon explained how the fees are calculated for rezoning applications. Mr. Simon stated that he finds the fees reasonable but described future plans to possibly bring the fee ordinance back under consideration.

In response to questions from Supervisor Kehoe, Mr. Simon confirmed that if fees were reevaluated by the Board of Supervisors, the process would be open for public comment.

By motion made, seconded (Baugh/Schappell), and unanimously carried, the Board of Supervisors took the following actions: Found the project to be statutorily exempt from the California Environmental Quality Act (CEQA) under CEQA Guidelines Section 15264 "Timberland Preserves"; adopted the rezoning findings as set forth in Planning Commission Resolution 2016-023; and introduced, waived the reading of, and adopted Ordinance No. 378-2039 to amend the Zoning Plan of the County of Shasta identified in Zone Amendment 16-004, Casey.
