 - Providing community leadership through partnerships to improve quality of life and economic vitality.



Shasta County Community Action Agency *"What We Do"*



- We provide services that address the problems caused by poverty and services that help prevent poverty
- Programs operated by CAA staff:
 - Short-Term Rental Assistance
 - Housing Rehabilitation
 - Down-Payment Assistance

Shasta CAA Community Services

- Core Funding Components:
 - Community Services Block Grant (CSBG)
 - Community Development Block Grant (CDBG)
 - Home Investment Partnerships Program (HOME)
 - Emergency Solutions Grant Program (ESG)
 - U.S. Department of Housing & Urban Development (HUD)
 - Emergency Food and Shelter Program (EFSP)

Community Services CSBG

- Federally Funded Block Grant
- Created by the federal Omnibus Budget Reconciliation Act of 1981
- A Core Funding Source for CAA's
- Provides Flexibility and Mobility for CAA's
- Designed to Assist Low-Income Families Up To 125% of Federal Poverty Level

CSBG 2017 Achievements

Local stories

- 3 unemployed persons were able to maintain a job working more than 30 hrs. per week for a period of at least 90 days
- 2 additional people were able to increase their employment income
- These are persons who were dependent on government assistance at time of enrollment

- FSS Program
 20 persons maintained a budget for more than 90 days
- 20 persons opened a savings account
- 2 persons pursued a post-secondary education
- 3 persons purchased assets with their saving accounts

CSBG Community Development Projects Housing Rehabilitation






- 8 Homeowners were able to have their homes brought back to decent, safe & code compliant
- 8 Contractors & staff were put to work
- 8 Neighborhoods were one house closer to being cleaned up

CSBG Community Partnership Projects

► EFSP

- Over 34,000 meals provided
- In 2016, 1280 shelter nights were provided

Total Funding: \$99,089




CSBG Community Partnership Projects

Increased homeless funding in Shasta County by \$295,587.00

Total Funding: \$642,862



Leveraging Funds What does CSBG allow staff to do???

- Shasta County Community Action Agency is awarded \$295,407 for the year 2018
 - In 2017, Shasta County Community Action Agency was awarded \$298,055 which leveraged:
 - \$450,000 short-term rental assistance program
 - Applying for \$236,229 rapid re-housing program (awarded in 2018)
 - Applying for \$59,358 in HMIS & planning grant money (still awaiting award)
 - Applying for \$75,000 in No Place Like Home technical assistance funds (still awaiting award)
 - Allocated \$99,089 to local food banks and emergency shelters
 - Administered multiple contracts for homeowners to receive repairs on their homes
 - Continued to build community partnerships through stakeholder meetings focused on:
 - Partnership Health Care Housing Grants
 - No Place Like Home Forums

Agency Accomplishments & Compliance

In 2017

- Shasta County CAA developed their first Strategic Plan for 2017-2020
 - Goal 1: Community Outreach--as we are doing today!
 - Goal 2: Board Capacity Building
 - ► Goal 3: Results, Outcomes & Data
- Completed 81 of the 90 Organizational Standards!!-90%
- New Leadership & new partnerships!
