# FIRST AMENDMENT TO THE AGREEMENT BETWEEN THE COUNTY OF SHASTA AND REDDING RECORD SEARCHLIGHT FOR ADVERTISING SERVICES

Display ads: \$7.00/per column inch; Liner ads: \$0.70/per line Auto pickup to online at <a href="www.legalnotice.org">www.legalnotice.org</a> (our legal notice online partner) Price for the online order for each legal ad is 11% of the print liner or display ad cost.

### II <u>REAFFIRMATION</u>

In all other respects, the Agreement, as amended, and any attachments, remains in full force and effect.

### III ENTIRE AGREEMENT

The Agreement, as amended, and any attachments, constitute the entire understanding between Advertiser and Publisher.

### VI <u>EFFECTIVE DATE</u>

Unless otherwise provided, this First Amendment shall be deemed effective as of the last date it is signed by both parties.
