FIRST AMENDMENT TO THE

PERSONAL SERVICES AGREEMENT BETWEEN

THE SHASTA COUNTY WATER AGENCY AND PACE ENGINEERING, INC.

This First Amendment is entered into between the Shasta County Water Agency ("Water Agency") and Pace Engineering, Inc., ("Consultant").

RECITALS

WHEREAS, Water Agency and Consultant have previously entered into an agreement that commenced on June 28, 2016, (the "Agreement") for the purpose of providing engineering and administrative services for a water system improvement project for County Service Area ("CSA") No. 2 - Sugarloaf Water ("Keswick") (the "Original Agreement"); and

WHEREAS, Water Agency and Consultant desire to amend the responsibilities of Consultant, increase the maximum amount of compensation payable to Consultant by \$992, and increase the term of the Agreement to end on March 30, 2018;

NOW, THEREFORE, the Agreement is amended as follows:

- **I.** Subsections A.10 and A.12 of Section 1 of the Agreement entitled RESPONSIBILITIES OF CONSULTANT are amended to read as follows:
 - A.10 Prepare draft Preliminary Report ("PR") following Drinking Water Sate Revolving Fund ("DWSRF") format and issue a copy in Portable Document Format ("PDF") to Water Agency for distribution to DWSRF and State Water Resources Control Board Division of Drinking Water ("DDR").
 - A.12 Prepare final PR and issue final copy to Water Agency in PDF.
- **II.** Subsections A.14 is added to Section 1 of the Agreement entitled RESPONSIBILITIES OF CONSULTANT to read as follows:
 - A.14 Assist the Water Agency in preparation of a DWSRF Planning Assistance application.
- **III.** Section 3 of the Agreement entitled COMPENSATION is amended in its entirety to read:

Section 3. COMPENSATION

Effective June 28, 2016, Consultant shall be paid on a time and materials basis according to the rates described in Exhibit A, attached and incorporated herein, for the services described in this agreement. In no event shall the maximum amount payable under this agreement exceed \$40,800.

IV. Section 5 of the Agreement entitled TERM OF AGREEMENT is amended in its entirety to read:

Section 5. TERM OF AGREEMENT

This Agreement shall commence June 28, 2016, and shall end on March 30, 2018.

V. REAFFIRMATION

In all other respects, the Agreement, as amended, any attachments, remains in full force and effect.

VI. ENTIRE AGREEMENT

The Agreement, as amended, and any attachments and exhibits hereto, constitutes the entire understanding between County and Consultant concerning the subject matter contained herein.

VIII. EFFECTIVE DATE

Unless otherwise provided, this First Amendment shall be deemed effective as of the date it is signed by both parties.
