THIRD AMENDMENT TO THE PERSONAL SERVICES AGREEMENT BETWEEN THE COUNTY OF SHASTA AND ENPLAN

This Third Amendment is entered into between the County of Shasta, a political subdivision of the State of California through the Department of Public Works ("County"), and Randall J. Hauser dba ENPLAN, ("Consultant"), a sole propietorship.

RECITALS

WHEREAS, County and Consultant have previously entered into an agreement on February 26, 2013, (the "Agreement") for the purpose of providing environmental consulting and/or compliance services or other similar related services; and

WHEREAS, the Agreement was amend on August 18, 2015 (the "First Amendment"); and

WHEREAS, the Agreement was amend on February 1, 2016 (the "Second Amendment"); and

WHEREAS, the Consultant is engaged in environmental consulting services on County projects that will not be completed before the term of the Agreement; and

WHEREAS, County and Consultant desire to extend the term of the Agreement to end no later than February 23, 2018;

WHEREAS, County and Consultant desire to amend the rates set forth in Exhibit A;

NOW, THEREFORE, the Agreement is amended as follows:

I. Section 5, "TERM OF AGREEMENT" of the Agreement is amended in its entirety to read as follows:

Section 5. TERM OF AGREEMENT.

This agreement shall commence on February 26, 2013, and shall end no later than February 23, 2018.

II. Exhibit A of the agreement is amended in its entirety by Exhibit A, which is attached to this Third Amendment and incorporated herein.

III. REAFFIRMATION

In all other respects, the Agreement, as amended, and any attachments, remains in full force and effect.

IV. ENTIRE AGREEMENT

The Agreement, as amended, and any attachments and exhibits hereto, constitutes the entire understanding between County and Consultant concerning the subject matter contained herein.

V. <u>EFFECTIVE DATE</u>

Unless otherwise provided, this Third Amendment shall be deemed effective as of the last date it is signed by both parties.
