

**RESOLUTION NO. 2017-**  
**RESOLUTION OF THE BOARD OF SUPERVISORS**  
**OF THE COUNTY OF SHASTA**  
**PROCLAIMING CONTINUATION OF A LOCAL EMERGENCY**  
**DUE TO STORM AND FLOOD DAMAGE**  
**OCCURRING IN JANUARY AND FEBRUARY 2017**

**WHEREAS**, Section 2.72.060, Shasta County Code of the County of Shasta empowers the Director of Emergency Services to proclaim the existence or threatened existence of a local emergency if the Board of Supervisors is not in session; and

**WHEREAS**, California Government Code section 8630 empowers the Board of Supervisors to proclaim the existence of a local emergency; and

**WHEREAS**, conditions of extreme peril to the safety of persons and property arose within the County of Shasta, in that on January 9, 2017, road and culvert damage was discovered on Whiskey Creek Road and a slide occurred on Big Bend Road, in an unincorporated area of the County of Shasta; and

**WHEREAS**, extreme and hazardous weather conditions continued thus exacerbating the conditions of extreme peril to safety of persons and property and hindering efforts to abate or mitigate those conditions; and

**WHEREAS**, on January 18, 2017, the Shasta County Public Works Director advised the Sheriff that there was already over \$300,000 of infrastructure damage, including damage to roads, culverts and above average snow removal cost as a result of recent storms; and

**WHEREAS**, there are unbudgeted costs to repair a slide which occurred on Big Bend Road as a result of recent storms; and

**WHEREAS**, the storm events caused significant damage to Whiskey Creek Road resulting in the road being impassable; and

**WHEREAS**, the Public Works Department has also incurred an additional \$50,000 in overtime and materials costs to do emergency road opening work on storm damaged roads; and

**WHEREAS**, conditions from the initial proclamation of a local emergency had not been remedied and new storms continued to hamper and delay the County's ability to respond to the local emergency conditions; and

**WHEREAS**, the Board of Supervisors was not in session and on January 19, 2017 the Director of Emergency Services of the County did proclaim the existence of a local emergency within the County of Shasta as a result of storm damage and after consideration of the information provided by the Public Works Director; and

**WHEREAS**, on January 23, 2017, the Governor issued two Proclamations of a State of Emergency, both of which included County of Shasta; and

**WHEREAS**, on January 24, 2017, the Board of Supervisors found that the aforesaid conditions of extreme peril that directly endangered persons and property within unincorporated and incorporated areas of the County warranted and necessitated the proclamation of the existence of a local emergency and adopted Resolution No. 2017-009; and

**WHEREAS**, on January 24, 2017, the Shasta County Board of Supervisors proclaimed and ordered that during the existence of this local emergency, the powers, functions, and duties of the Director of Emergency Services and the emergency organization of this county shall be those prescribed by state law, ordinances and resolutions of this county approved by the Board of Supervisors, and by the Shasta Operational Area Emergency Operations Plan, as approved by the Board of Supervisors; and

**WHEREAS**, on January 24, 2017 the Shasta County Board of Supervisors ratified the proclamation of a "local emergency" by the Director of Emergency Services by adopting Resolution No. 2017-009 and proclaimed and ordered that said local emergency shall be deemed to continue to exist until its termination is proclaimed by the Board of Supervisors of the County of Shasta, State of California and that the Shasta County Board of Supervisors shall review the need for continuing the local emergency at least once every 30 days until its termination is proclaimed by the Shasta County Board of Supervisors; and

**WHEREAS**, a copy of the January 24, 2017 Shasta County's declaration was forwarded to the Governor of California; and

**WHEREAS**, a copy of the January 24, 2017 Shasta County's declaration was forwarded to the California Office of Emergency Services; and

**WHEREAS**, on February 5, 2017, another significant rain event began and caused additional damage in parts of the unincorporated and the incorporated areas of the County, which included major damage, above and beyond the damage previously reported to the Board of Supervisors; and

**WHEREAS**, in the early morning hours of February 6, 2017, evacuations were ordered in the area of Wonderland Boulevard due to localized flooding of creeks and tributaries and a temporary Red Cross Shelter was opened for local residents affected by the evacuations; and

**WHEREAS**, local flooding also damaged several businesses and private residences in and around the area of Shasta Lake City; and

**WHEREAS**, additional damages known as of February 7, 2017 were in the area of Keswick Dam Road (City of Redding); Williamson Road and Hot Springs Road (unincorporated area); and damage to roadways within the City of Anderson; and

**WHEREAS**, the National Weather Service predicted additional storms to hit Shasta County over the next several days after February 7, 2017; and

**WHEREAS**, on February 7, 2017, the Board of Supervisors recognized that the circumstances that led to the January 24, 2017 proclamation ratification continued to exist and adopted Resolution No. 2017-014 to continue the proclamation; and

**WHEREAS**, on February 10, 2017, citing higher than normal water releases from Shasta and Keswick dams, the Shasta County Sheriff closed the Sacramento River to boating and other recreation for public safety; and

**WHEREAS**, on or about February 12, 2017, the flows out of Keswick Dam increased even higher, to about 70,000 cfs, and on February 13, 2017, the release went up to 79,000 cfs, causing flooding around the low level areas of the incorporated cities of Redding and Anderson, and the unincorporated areas of Shasta County; and

**WHEREAS**, on February 14, 2017, the Federal Emergency Management Agency (FEMA) approved a Major Disaster Declaration DR-4301 for California Severe Winter Storms, Flooding, and Mudslides for the incident period January 3, 2017 to January 12, 2017, of which Shasta County was included on the declaration map as an area eligible for assistance under the Hazard Mitigation Grant Program; and

**WHEREAS**, as of February 27, 2017, the releases from Keswick Dam will continue to remain at unsafe levels for the public, thus a full assessment cannot be accurately made until such levels are reduced significantly; and

**WHEREAS**, as of February 27, 2017, there are still several road closures in the incorporated and unincorporated parts of Shasta County; and

**WHEREAS**, conditions from the initial proclamation of a local emergency have not been remedied and flooding continues to hamper and delay the County's ability to respond to the local emergency conditions; and

**WHEREAS**, the Board of Supervisors recognize that the circumstances that led to the January 24, 2017 proclamation ratification and the February 7, 2017 continuation of the proclamation ratification continue to exist.

**NOW, THEREFORE BE IT FURTHER RESOLVED AND PROCLAIMED**, by the Board of Supervisors of the County of Shasta that a local emergency due to storm damage and flooding continues to exist throughout Shasta County.

**NOW, THEREFORE BE IT FURTHER RESOLVED**, by adopting this resolution, this Board of Supervisors is requesting further assistance via the State of California, California Disaster Assistance Act (CDAA) and other federal and state agencies are requested to provide financial and other assistance to residents and local governments to assist with the financial burdens imposed by the January 2017 and February 2017 storm damage and associated flooding; and

**NOW BE IT FURTHER RESOLVED, PROCLAIMED, AND ORDERED** that this Board of Supervisors shall review the need for continuing the local emergency at least once every 30 days until its termination is proclaimed by this Board.
