DISCUSSION

The California Air Resources Board ("CARB") provides incentive grants for cleaner-than-required engines, heavy equipment and other sources of pollution providing early or extra emission reductions through its Carl Moyer Memorial Air Quality Standards Attainment Program ("Carl Moyer Program"). CARB provides annual Carl Moyer Program fund allocations to participating local air districts, which in

turn provide matching co-funds or in-kind administrative support and administer grant programs for the benefit of the local air district. Both the District and SCAPCD participate in the Carl Moyer Program. The MOU would allow the District to transfer up to \$640,000 of unexpended Carl Moyer Program Year 18 funds to the SCAPCD prior to the expenditure deadline of June 30, 2020. Due to a decline in project eligibility combined with a reduced number of project applications received within Shasta County, the District is forecasting a surplus of Year 18 funds at the expenditure deadline. As a result, the District has coordinated with SCAPCD to identify projects located in Siskiyou County that the funds can be applied to thereby providing a regional air quality benefit. CARB policies allow and encourage air pollution control districts to assist and support fellow air pollution control districts whenever possible.

ALTERNATIVES

The Board may choose to: (1) not approve the MOU which would mean that at the expenditure deadline, any unexpended funds would be returned to CARB; or (2) ask for more information.

OTHER AGENCY INVOLVEMENT

Shasta County Counsel and Risk Management have reviewed the MOU and Resolution. Shasta County Administration has reviewed this recommendation.

FINANCING

The Shasta County Program has been funded by a grant of \$803,536 from the California Air Resources Board Carl Moyer Attainment Program. A portion of these funds will be transferred to SCAPCD as approved by the CARB according to the Carl Moyer Program guidelines described in the MOU. Budgeting for this Program has been included in the Fiscal Year 2018/2019 budget process.

MEMORANDUM OF UNDERSTANDING BETWEEN THE SISKIYOU COUNTY AIR POLLUTION CONTROL DISTRICT AND THE SHASTA COUNTY AIR QUALITY MANAGEMENT DISTRICT COLLABORATIVE IMPLEMENTATION OF CARL MOYER PROGRAM FUNDS

This Memorandum of Understanding (MOU) is entered into between the Siskiyou County Air Pollution Control District (Siskiyou County APCD) and the Shasta County Air Quality Management District (Shasta County AQMD) hereafter referred to collectively as the "Parties" or "Districts". The MOU defines the scope of activities for the expenditure of California Air Resources Board (CARB) Carl Moyer Program Grant (CMP) funds from program Year 18.

1.0 RECITALS

- 1.1 WHEREAS, The Shasta County AQMD applied for and received an award from the California Air Resources Board (CARB) for CMP funding Year 18 of the program;
- 1.2 WHEREAS, The Shasta County AQMD elected to implement the Carl Moyer program for Year 18 funding, and has funds remaining;
- 1.3 WHEREAS, The Siskiyou County APCD is implementing a CARB qualified Carl Moyer Program;
- 1.4 WHEREAS, The Siskiyou County APCD is authorized to and has CARB approval to accept the transfer of unexpended Carl Moyer Program Year 18 funds from the Shasta County AQMD; and
- 1.5 WHEREAS, The Siskiyou County APCD has identified projects that can utilize excess Year 18 Carl Moyer Funds from the Shasta County AQMD.

NOW, THEREFORE, in consideration of the mutual promises hereafter set forth, the Siskiyou County APCD and the Shasta County AQMD agree as follows:

2.0 TERMS AND CONDITIONS

- 2.1 <u>Purpose of MOU.</u> The purpose of this MOU is to set forth the expectation of the Shasta County AQMD and the Siskiyou County APCD regarding the funding of CARB qualified CMP Projects, and authorizes the Air Pollution Control Officers of the Shasta County AQMD and the Siskiyou County APCD to redirect funds according to the California Air Resources Board Carl Moyer Program (CMP) procedures throughout the term of this MOU.
- 2.2 <u>*Terms of MOU.*</u> The term of this MOU will commence upon the execution by all parties and terminate June 30, 2020. This MOU will cover the multi-district CMP funding period defined as Moyer Year 18. Either party may terminate this MOU upon 30 days advanced written notice.

- 2.3 <u>*Payment.*</u> The Shasta County AQMD authorizes redirection of funds to the Siskiyou County APCD in an amount up to \$640,000 for expenditure on CARB qualified CMP Projects.
- 2.4 <u>*Transfer of Funding.*</u> The funds shall be transferred within forty-five (45) days of the execution of this MOU by all parties and shall occur directly through bank check payable to the Siskiyou County APCD at the address identified in the Notices and Communication section of this MOU, following CARB approval. Checks shall be sent via prepaid, return receipt requested, certified mail.
- 2.5 <u>Expenditure of Funds.</u> The Siskiyou County APCD agrees to expend the Carl Moyer Program funds provided by the Shasta County AQMD in accordance with the laws and guidelines of the Carl Moyer program by June 30, 2020, including the return of any funds not expended by June 30, 2020 to CARB.
- 2.6 <u>*Match Funding.*</u> The Siskiyou County APCD shall be responsible for any and all match funding obligations associated with the redirected funds.
- 2.7 <u>Indemnification and Insurance.</u> The Parties shall indemnify, defend and hold harmless each other and their respective officials, officers, agents, employees, and volunteers from and against any and all claims, demands, losses, damages, liability, costs, and expenses of whatever nature including court costs and reasonable attorney fees, whether for damages or loss of property, injury to or death of person, or economic or consequential loss arising from or related to or claimed or alleged to have arisen from or been related to the negligence of the indemnifying party in the performance of its obligations under this MOU.

The Shasta County AQMD and the Siskiyou County APCD shall each maintain and keep in force at their sole cost and expense the following insurance, or participation in program(s) of self-insurance, during the full term of this MOU:

- A. Commercial General Liability to include coverage for owned and nonowned automobiles in the amount of not less than \$1 million per occurrence.
- B. Errors and omissions coverage with limits of liability of not less than \$1 million per occurrence.
- C. Workers' Compensation as required by the laws of the State of California, and Employers Liability with a limit of not less than \$1 million per occurrence.

Certification of coverage will be provided upon request of one Party to the other Party.

2.8 <u>Notification to CARB.</u> The Shasta County AQMD shall notify CARB of the intended redirection of funds, and shall complete and forward all CARB required documentation within applicable timeframes in the current version of the CMP guidelines.

2.9 <u>Notices and Communication.</u> All written communications, notices and documents required under this MOU must be either personally delivered or sent by prepaid, first class mail, return receipt requested, unless the Parties agree in writing that notification by facsimile and/or email is adequate. Correspondence shall be addressed as follows:

Either Party may change the address for correspondence upon written notice to the other party.

- 2.10 <u>Audit of Records.</u> Both Parties shall maintain financial records as required by applicable CMP guidelines, and either District shall have access to such financial records held by the other District as necessary to perform audits. Each District shall provide the other District access, at all reasonable times, to all documents retained by that District in connection with all funds transferred and expended under this MOU. All records held by both parties shall be maintained for five (5) years after the termination of this MOU.
- 2.11 <u>Severability</u>. If any provision of this MOU is held invalid or unenforceable, its invalidity or unenforceability will not affect any other provisions of this MOU, and this MOU will be construed and enforced as if the invalid or unenforceable provision had not been included.
- 2.12 <u>Statutory Limitations.</u> This MOU and any payments for compensation and expenses are subject to the provisions and limitations imposed by federal and state law. Neither party shall have liability for payment of any compensation and expenses that are found to be in contravention of federal or state law.
- 2.13 <u>Authority to Bind.</u> The persons signing on behalf of the Parties to this MOU warrant that they have the legal authority to execute this MOU.

APCB - RESOLUTION NO. 2019-X

A RESOLUTION OF THE AIR POLLUTION CONTROL BOARD OF THE SHASTA COUNTY AIR QUALITY MANAGEMENT DISTRICT AUTHORIZING A MEMORANDUM OF UNDERSTANDING FOR COLLABORATIVE IMPLEMENTATION OF CARL MOYER PROGRAM FUNDS

WHEREAS, the Shasta County Air Quality Management District (District) can assist or receive assistance from other air pollution control districts in either the complete or partial implementation and operation of their Carl Moyer Programs; and

WHEREAS, the District's Air Pollution Control Board believes that giving assistance to or receiving assistance from other air pollution control districts in the operation of their Carl Moyer Program provides an atmosphere of cooperation, collaboration, teamwork, and support in operating and maintaining programs that work mutually to reduce air pollution and improve air quality in the state of California; and

WHEREAS, that by assisting other air pollution control districts with their Carl Moyer Programs, it is expected to have no negative effect on the District's operating budget; and

WHEREAS, California Air Resources Board (CARB) policies allow and encourage air pollution control districts to assist and support fellow air pollution control districts whenever possible.

NOW, THEREFORE, BE IT RESOLVED that the Shasta County Air Pollution Control Board hereby:

- Authorizes the District to enter into a Memorandum of Understanding (MOU) with the Siskiyou County Air Pollution Control District (SCAPCD), commencing upon execution by all Parties and terminating on June 30, 2020, for the redirection of up to \$640,000 of unexpended Carl Moyer Program Year 18 funds from the District to the SCAPCD for expenditure by the SCAPCD on CARB qualified Carl Moyer Program projects; and
- 2) Appoints the Shasta County Air Pollution Control Officer, as the agent for the District, to conduct all negotiations and execute and submit the MOU and all documents necessary for the redirection of said funds.
- 3) Approve the attached budget amendment for FY 2018/19 increasing appropriations by \$640,000 in the Professional Grant Services expense account (034863) with use of Carl Moyer fund balance.
