RECOMMENDATION

On behalf of County Service Area (CSA) No. 2-Sugarloaf Water, approve and authorize the Chairman to sign an amendment, effective date of signing, to the agreement with PACE Engineering, Inc. to provide engineering and administrative services for the CSA No. 2-Sugarloaf Water Improvement Project, to increase compensation by \$267,700, for a new total not to exceed \$480,000, and retain the term date of signing through June 1, 2021.

SUMMARY

An amendment is proposed to an agreement with PACE Engineering, Inc. for CSA No. 2-Sugarloaf Water.

DISCUSSION

County Service Area (CSA) No. 2-Sugarloaf Water serves 47 customers near Lakehead. On June 28, 2016, the Water Agency entered into an agreement with PACE for engineering and administrative services. U.S. Department of Agriculture funding was sought to improve the CSA water system. On January 24, 2017, the PACE agreement was amended to pursue a Drinking Water State Revolving Fund (DWSRF) grant for a test well and compensation was increased by \$992. DWSRF subsequently provided a \$500,000 grant. On February 28, 2018, the PACE agreement was amended to drill a test well and compensation was increased by \$171,500. Additional work is proposed to put the well into production. PACE will also study and design improvements to address existing deficiencies elsewhere in the system.

ALTERNATIVES

The Board may decline to approve the proposed amendment. The well would remain an empty casing. Distribution system leaks are widespread.

OTHER AGENCY INVOLVEMENT

County Counsel has approved the amendment as to form. Risk Management has reviewed and approved the amendment. The County Administrative Office has reviewed this recommendation.

FINANCING

The ultimate project may entail up to \$2,400,000 in improvements. Adequate funds are included in the Adopted FY 2019/20 Water Agency budget for proposed consultant work. There is no General Fund impact.

THIRD AMENDMENT TO THE PERSONAL SERVICES AGREEMENT BETWEEN THE SHASTA COUNTY WATER AGENCY AND PACE ENGINEERING, INC.

This Third Amendment is entered into between the Shasta County Water Agency ("Water Agency") and Pace Engineering, Inc. ("Consultant").

RECITALS

WHEREAS, Water Agency and Consultant have previously entered into an agreement on June 28, 2016, for the purpose of providing engineering and administrative services for a water system improvement project for County Service Area ("CSA") No. 2-Sugarloaf Water ("Sugarloaf") ("Original Agreement"); and

WHEREAS, the Original Agreement was amended on January 24, 2017, to pursue a Drinking Water State Revolving Fund ("DWSRF") grant, increase compensation by \$992 (maximum amount payable not to exceed \$40,800), and extend the schedule to March 30, 2018 ("First Amendment"); and

WHEREAS, the First Amendment was amended on February 28, 2018, to design and construct a test well and prepare a technical memo describing test well results, increase compensation by \$171,500 (maximum amount payable not to exceed \$212,300), and extend the term of the Agreement to end June 1, 2021 ("Second Amendment"); and

WHEREAS, Water Agency and Consultant desire to further amend the responsibilities of Consultant at the new rates set forth in Exhibit A-2 and Exhibit B, attached and incorporated herein; and to increase the amount of compensation payable to Consultant by \$267,700 for a new total not to exceed \$480,000 ("Third Amendment"); and

WHEREAS, the Original Agreement, the First Amendment, the Second Amendment, and the Third Amendment are collectively referred to as the "Agreement."

NOW, THEREFORE, the Agreement is amended as follows:

- I. Subsections A.19 through A.23 are added to Section 1 of the Agreement entitled RESPONSIBILITIES OF CONSULTANT to read as follows:
 - A.19 Provide specifications and obtain submersible pump for additional well testing.
 - A.20 Coordinate additional well testing and reporting with the State Water Resources Control Board Division of Drinking Water and other interested agencies. Complete a Multi-Agency Project Report.
 - A.21 Prepare drawings and specifications suitable for County in-house use for connecting well to existing system.

- A.22 Prepare Environmental Document for construction, Geotechnical Report for tank construction, and perform surveying necessary for preparation of 90% drawings, specifications and contract documents described in section A.22.
- A.23 Prepare 90% drawings, specifications, and contract documents suitable for public bidding for constructing tank and distribution system improvements.
- II. Section 3 of the Agreement entitled COMPENSATION is amended in its entirety to read:

Section 3. COMPENSATION

Consultant shall be paid on a time and materials basis according to the rates set forth in Exhibit A-2 and Exhibit B, attached and incorporated herein, for the services described in this Agreement. In no event shall the maximum amount payable under this Agreement exceed \$480,000.

Consultant's violation or breach of Agreement terms may result in fiscal penalties, withholding of compensation, or termination of Agreement.

IV. Section 5 of the Agreement entitled TERM OF AGREEMENT is amended in its entirety to read:

Section 5. TERM OF AGREEMENT

This Agreement shall commence as of the date it has been signed by both Parties and shall end on June 1, 2021.

V. REAFFIRMATION

In all other respects, the Agreement, as amended, any attachments or exhibits, remains in full force and effect.

VI. ENTIRE AGREEMENT

The Agreement, as amended, and any attachments and exhibits hereto, constitutes the entire understanding between County and Consultant concerning the subject matter contained herein.

VIII. EFFECTIVE DATE

Unless otherwise provided, this Third Amendment shall be deemed effective as of the date it is signed by both parties.
